



**TERMS AND CONDITIONS FOR THE BLUEBEAN MASTERCARD CREDIT CARD SWIPE AND WIN
OUTBOUND CALL SMS OR E-MAIL PROMOTIONAL COMPETITION CONDUCTED BY BLUEBEAN A
DIVISION OF THE STANDARD BANK OF SOUTH AFRICA LIMITED ("THE PROMOTER")**

1 HOW TO PLAY

- 1.1 This promotional competition commences on 1 January 2012 at 08:00am and ends at midnight on 31 January 2012.
- 1.2 To qualify as an entrant into this promotional competition you must meet all of the following requirements ("The Requirements"):
- 1.2.1 You must receive an invitation to enter the promotional competition, either via outbound call, or sms, or letter via the post, or an e-mail from the Promoter, which will include the terms and conditions of the promotional competition.
- 1.2.2 Be a South African citizen.
- 1.2.3 Be 18 (eighteen) years old or older.
- 1.2.4 Hold a valid identification document.
- 1.2.5 Be the holder of a valid BlueBean MasterCard Credit Card account. ("Credit Card account").
- 1.2.6 Your Credit Card account must be paid up to date and must in good standing with the Promoter at the time of the lucky draw.
- 1.2.7 You must spend R 2000.00 or more on your Credit Card account during the period 1 January 2012 to 31 January 2012.
- 1.3 There are no entry forms to complete this promotional competition. Once you have met the above Requirements, you will automatically be entered into the promotional competition.
- 1.4 To stand a chance of winning the Additional Prize, you must meet all of the following requirements:



- 1.4.1 Be the prize winner of the First Prize set out in clause 2.1 below.
- 1.4.2 You must convert to a monthly debit order as your method of payment of your Credit Card account.
- 1.4.3 You must convert, from having your statements posted to you, to having your e-statements sent to you electronically.

2 THE PRIZE

- 2.1 1(one) entrant stands a chance to win back the same amount of money that he/she spent on his/her Credit Card account, during the period 1 January 2012 to 31 January 2012, which will be credited into his/her Credit Card account, up to a maximum amount of R 8000.00 (eight thousand rand) ("First Prize").
- 2.2 The prize winner in clause 2.1 above will have an additional R1 000.00 credited to his/her Credit Card account if he/she has met the specific requirements set out in clause 1.4 above ("Additional Prize").

3 GENERAL

- 3.1 The Promoter of the competition is BlueBean a division of The Standard Bank of South Africa Limited ("the Promoter").
- 3.2 The Promoter, its directors, members, partners, employees, agents or consultants and their spouses, life partners, parents, children, siblings, business partners, associates or competitors are not eligible to participate in or enter this competition.
- 3.3 All information relating to this competition and published on any promotional or advertising material forms part of the terms and conditions of entry.
- 3.4 No entry will be considered to be valid until a validation process has taken place.
- 3.5 The prizes will only be awarded to the prize winner upon valid and satisfactory proof of identification.
- 3.6 The First Prize winner shall be chosen by means of a lucky draw conducted by the internal audit division of the Promoter. The lucky draw will be held on Wednesday, 3 February 2012 at the Premises of the Promoter, situated at 6 Simmonds Street, Johannesburg ("the lucky



draw"). The first entrant drawn from the lucky draw will win the First Prize set out in clause 2.1 and will become eligible to win the Additional Prize in clause 2.2.

- 3.7 If the First Prize winner meets the requirements set out in clause 1.4 above, he/she will automatically receive the Additional Prize.
- 3.8 The prize winner will be notified by the Promoter by telephone, alternatively by e-mail, via the contact details listed in the Promoter's database, within 10 (ten) working days after the lucky draw.
- 3.9 The Promoter will credit the prize winner's Credit Card account, with the First Prize and with the Additional Prize, where applicable, within 48 hours of notification to the prize winner. Prizes are not transferable and should the Promoter be unable to contact the prize winner after a 12 (twelve) month period, from the date of the draw, the First Prize shall be subject to a separate draw and shall be allocated in terms of this promotional competition.
- 3.10 In the event of a dispute, the decision of the Promoter will be final and binding on all aspects of this competition and no correspondence will be entered into.
- 3.11 The Promoter, its directors, members, partners, employees, agents, consultants, suppliers, contractors and sponsors assume no liability whatsoever for any direct or indirect loss or damage arising from an entrant's participation in this competition or for any loss or damage, howsoever arising.
- 3.12 The Promoter will be entitled to publish the prize winner's names and photographs in any advertising, promotional, print, point of sale or public relations material, the nature and manner of such releases to be determined within the sole discretion of the Promoter, for a period of 12 (twelve) months from the date of the lucky draw provided that the prize winners consent in writing to such usage, after having being publicly announced as the prize winners of this competition.
- 3.13 If required by the Minister for Trade and Industry, the Lotteries Board or for whatever other reason, the Promoter will have the right to terminate this competition with immediate effect and without notice of such termination. In such event, all entrants hereby waive any rights, which they may have against the Promoter and hereby acknowledge that they will have no recourse or claim of any nature whatsoever against the Promoter, its directors, members, partners, employees, sponsors, agents or consultants.
- 3.14 All entrants, by entering this competition, agree to be bound by these terms and conditions.



- 3.15 Subject to clause 3.16 below, the prize will not be changed for cash amounts or for any other prize other than the prize offered in terms of clause 2 (two) above.
